ELIGIBILITY

1. To be eligible to participate in the Promotion you must be aged 18 or over and residing in the UK, Isle of Man, Jersey or Guernsey ('Participant'). Businesses are excluded from participating in this Promotion except for business customers purchasing or upgrading to the Qualifying Product(s) through Carphone Warehouse customer accounts ('Business Customer').
